

Minutes of the Meeting of High Level Monitoring Committee (HLMC) on SDGs

Date: 21st July, 2017
Time: 4.00 PM
Venue: Conference Hall No.2
Subject: Meeting of High Level Monitoring Committee (HLMC) under the Chairmanship of Chief Secretary, Government of Tripura.

Chief Secretary welcomed all HLMC members and other officers of the State Government and highlighted the importance for achieving the Sustainable Development Goals (SDGs) by 2030.

2. Principal Secretary, Planning gave a overall background of the SDGs vis-à-vis Millennium Development Goals (MDGs) and emphasized that SDGs allow for emphasis on local requirements. He pointed out that Planning (P&C) Department has attempted and prepared a draft Vision, Strategy and Indicator document and placed in the HLMC for consideration.

3. Principal Secretary, Education pointed out that professional support of UN officials are required in finalization of the draft Vision, Strategy and Indicator.

4. Principal Secretary, Finance requested that more indicators are to be incorporated to cover sub-points of the each SDGs and one officer from the Planning Department should be included in the working groups.

5. Principal Secretary, Urban Development emphasized that the Vision document needs to be owned by the Government and reflected in its routine business & plans.

6. Director Planning elaborated on goal wise SDG wise draft Vision.

7. After detailed discussion, following decisions were arrived at:

7.1 Four working groups are to be formed for- i) Social (SDGs 1 to 6) ii) Economic (SDGs 7 to 11) iii) Environment (SDGs 12 to 15) and iv) Peace, Justice and Partnership (SDGs 16 & 17) for finalization and making a reliable Vision, Strategy and Indicator document.

7.2. Working Group on Social Sector will be headed by the Principal Secretary, Education, Working Group on Economic Sector will be headed by the Principal Secretary, Finance, Working Group on Environment Sector will be headed by the Principal Chief Conservator of Forest (Wild Life) and Working Group on Peace, Justice and Partnership sector will be headed by the Principal Secretary, Planning.

7.3 The Working Groups may co-opt officers from the concerned Departments as per their requirement.

7.4 The UNDP representative present agreed to provide 2 consultants for at least three months for providing professional support to the working groups by to prepare a draft Vision, Strategy and Indicator document.

7.5 All Departments should give priority to the SDGs related work in finalization of the draft Vision, Strategy, Indicator document. State specific issues shall be reflected in the draft.

7.6 The draft documents shall have to be finalized within a month and progress of work will be reviewed after a month.

7.7 Suggested list of Departments concerned mapped with individual SDGs is given in Annexure-B. This is only an illustrative lists and not exhaustive and may be finalized by concerned working group.
