



3. The terms of reference (ToR) of the Forum would be as under:

- i. To identify various constraints on the way for accelerated, inclusive but sustainable economic growth in the North East Region of the country and to recommend suitable interventions for addressing identified constraints.
- ii. To review the development status in NER
- iii. Any other issue as deemed relevant.

4. The Chairman/Co-Chairman of the Forum may co-opt any other official/ nonofficial representative of any organization as a member (s), if required.

5. The Forum may examine and address any other issues which are of importance but not specifically spelt out in the ToR. The Forum may devise its own procedure to conduct its business/ meetings/ field visits/ constitution of Sub- Groups etc.

6. The Expenditure of the members on TA/DA in connection with the meeting of the Expert Group will be borne by the parent Department/ Ministry/ Organization/ State Government for official members. For non-official members, M/o DoNER will bear the TA/ DA as admissible to Class -I officers of the Government of India. The non- official members

have to book their air ticket by Air India (restricted to economy class) only either on Air India website directly or through authorized Government travel agencies i.e. M/s Balmer & Lawrie or M/s Ashok Travels and Tour or IRCTC. The air travel by private airlines is not permissible and TA/DA claim will not be reimbursed.

7. The Secretariat for the Forum will be in the Ministry of DoNER.
